Direction to DLCD/LCDC	Make changes to the statewide land use planning goals, including by amending existing goals or adopting additional goals, to support climate change adaptation and mitigation and environmental justice for disadvantaged communities.	A single new Goal 20 to address climate change responses, equity and environmental justice
Timeline for completion of goal changes	December 31, 2026	June 30, 2023
Climate change obligations on local governments through goal changes	Broad and less defined	Updates of major comprehensive plan elements and UGB expansions, avoidance of carbon storage areas. Local governments required to address climate impact, as well as the GHG emissions and carbon storage gain/loss, associated with these decisions. Smaller and local land use decisions flow from the comprehensive plan elements.

<p>Implementation schedule</p>	<p>90 days after adoption for large cities/counties, 270 days after adoption for mid-sized cities/counties, and 540 days after adoption for small cities/counties</p>	<p>For all obligations under Goal 20</p> <ul style="list-style-type: none"> - <u>June 30, 2025</u> (i.e. two years after adoption) for cities > 25,000 and counties > 100,000 and for a metropolitan service district. - <u>June 30, 2026</u> for cities 10,000 – 25,000 and counties 30,000 - 100,000. - <u>June 30, 2027</u> for cities 4,000 – 10,000 and counties 20,000 – 30,000. <p>For equity & EJ obligations only under Goal 20:</p> <ul style="list-style-type: none"> - <u>June 30, 2027</u> for cities < 4,000 and counties < 20,000 <p>For climate obligations under Goal 20:</p> <ul style="list-style-type: none"> - Cities < 4,000 and counties < 20,000 are not subject to these obligations but may voluntarily opt into them at any time. Requirement that that these funds be prioritized for less well-resourced local governments.</p>

Funding priority for small cities and counties	Not mentioned	Technical assistance will be prioritized for cities and counties with fewer resources and must be distributed throughout the regions of the state.
