Town Hall Panel and Community Dialog: Forestry, Herbicides and Health

Jan. 15th meeting to be moderated by Lincoln County Commissioner Bill Hall

EUGENE, ORE. — Modeled after successful meetings held in other Oregon coastal towns that drew hundreds of people, residents of Newport have organized a town hall style meeting. On January 15 a panel of six expert speakers will talk about topics such as the Oregon Forest Practices Act, human health impacts of pesticides, legal and economics and trends in forestry. Included on the panel will be private consultants, as well as, representatives from Oregon Health Department and Oregon Department of Environmental Quality.

The Town Hall is being organized by a coalition of coastal residents and is sponsored by Beyond Toxics, an Oregon non-profit actively engaging rural communities to learn about protecting drinking water from the threat of forestry herbicide use. The free event will be held **January 15, 2015 at the Newport High School Library**. A light dinner will be served at 5:30 pm (\$6 donation) and the program begins at 7:00 pm.

The forest directly above Newport's drinking water reservoir is owned by Plum Creek Timber Company. This area and other coastal forestland have been targeted for clearcutting in 2015. Herbicides will likely be sprayed and since Oregon has no requirements for buffers around non-fish bearing streams that flow into the rivers that provide drinking water, many residents of Newport have expressed concern.

One such Newport resident who has expressed concern is Maria Sause, who learned about a similar town hall in the coastal town of Rockaway Beach last September. "People must become aware of unseen and unfelt dangers of pesticides in the local environment," says Maria. "Pesticides can make us sick in the long-term. We have no adequate testing and very little knowledge of the risks of combinations of chemicals in our bodies."
