### July 28<sup>th</sup> Resilient Forestry Tour

*Hosted by Willow-Witt Ranch and Beyond Toxics*

**Ashland, ORE.** – Beyond Toxics and the owners of Willow-Witt Ranch will host a Resilient Forestry Tour on Saturday, July 28<sup>th</sup> from 11:30 am – 3:00 pm.

This tour provides the community a unique opportunity to look inside a sustainably-managed forest and see how this approach creates healthy ecosystems and sequesters carbon while sustaining healthy air and water in the face of climate change. Suzanne Willow and Lanita Witt, owners of the Willow-Witt Ranch will guide community members through a working forest and wetland and highlight their management practices that focus on non-toxic management, environmental protection, wildlife and botanical biodiversity, and carbon storage. Topics such as caring for rich soil and honoring the development of slow growth trees and undisturbed wetlands without the use of synthetic herbicides and fertilizers will be discussed. Beyond Toxics Executive Director Lisa Arkin will give remarks on state climate legislation and the role of forestry to reduce carbon emissions.

These tours of forests using “Resilient Forestry” practices provide a glimpse of the future of modern forestry that will serve both human needs and forest biodiversity to better adapt to the challenges of climate change.

Located 30 minutes outside of Ashland, Willow-Witt Ranch is a 445-acre gem in Southern Oregon’s high country. The tour is part walking and part bus transportation. Total walking distance is about 1 to 1.5 miles and the trails are level. Tennis shoes would work fine. No dogs allowed on premises.
